



# PRIVACY POLICY

## **1. Ownership of Media**

All images, video, audio, and other media captured during the course of our projects and productions are the sole property of **COLLABZ. Multi-Media Inc.** This includes but is not limited to:

- Photographs
- Film or video recordings
- Audio recordings
- Digital media or any other form of media captured

We reserve the right to use, modify, distribute, and display these materials for any purpose, including promotional, advertising, and commercial use, without limitation.

## **2. Performance Release**

By participating in any COLLABZ. Multi-Media production or event, you agree to the following terms:

- **For good and valuable consideration**, the receipt of which is hereby acknowledged, you grant to COLLABZ. Multi-Media Inc., and/or **Alex Gustavo Siles** (Producer/Director) or its authorized representatives, assigns, or licensee(s), the unrestricted right and license to record, film, photograph, tape, and otherwise capture and reproduce in any manner, your image, name, stage name, voice, likeness, and information about you (collectively referred to as your "Performance").
- This includes the right to use your Performance in all forms and media, including composite or modified representations, for all purposes, including advertising, trade, or any commercial purpose throughout the world and in perpetuity.
- Producer shall have the right to use any biographical material that you furnish. All images and sound captured during the project shall be referred to as the "Recordings."

## **3. Rights and Ownership of Recordings**

- You agree that COLLABZ. Multi-Media Inc. (the "Producer") shall:
  1. **Own all rights** in the Recordings.
  2. Have the right to **use the Recordings**, in whole or in part, in any media, now existing or created in the future.
  3. Be entitled to use the Recordings for any purpose, including but not limited to promotion, advertising, and publicity, in perpetuity and throughout the universe.

- **Media** for purposes of this agreement includes television, broadcasts, newspapers, magazines, outdoor advertising, digital platforms, and the internet.
- Your participation shall be considered a **work-made-for-hire** under applicable copyright laws, and the Producer shall exclusively own all rights to the Recordings and related media in perpetuity.

#### **4. Waivers**

You agree to waive the following:

- **Right to inspect or approve** the use of any Recordings or their derivatives.
- **Right to injunctive relief** or to revoke this agreement.
- **Any moral rights** you may have in the Recordings.

#### **5. Release and Indemnification**

You release and agree to hold harmless **COLLABZ. Multi-Media Inc., Alex Gustavo Siles**, and their successors, assigns, and licensees from any and all claims, demands, damages, liabilities, or lawsuits related to the use of the Recordings. This includes reasonable attorney's fees that may arise from the use of your Performance as part of any project.

#### **6. Additional Obligations**

You agree to adhere to the schedule set forth prior to your engagement. If required, you will make yourself available for additional sound or voice-over work related to the project. If you are unable to perform such work, Producer reserves the right to hire another person to re-record dialogue or perform voice-overs as necessary.

#### **7. Data Collection**

We may collect certain personal data during production or in the process of communicating with you. This includes but is not limited to:

- Contact information (name, email, phone number)
- Biographical information
- Other relevant data necessary for production or project collaboration.

Your personal information will be used strictly for the purposes of communication, production management, and legal obligations.

#### **8. Data Protection**

We are committed to maintaining the privacy of your personal information and ensuring that it is only used in accordance with this policy. We do not share, sell, or distribute your data to any third party except for project-related purposes or legal requirements.
